THE SANCTUARY IS A RESCUE ORGANIZATION AND IS NOT OPEN TO THE PUBLIC. COMBINING NATURAL AND SPACIOUS HABITATS WITH A LIFE FREE OF EXHIBITION, TWS ALLOWS ALL RESIDENTS TO LIVE WILD AT HEART.
